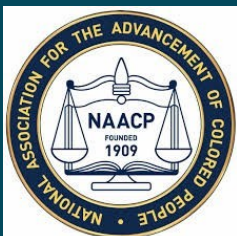

Conditions of Space Rental & Participation

Participation in this event is subject to the following conditions:

1. All payments are due and payable in full and are non-refundable. Space provided is 10' X 10'.
2. Company Representative/ Vendor/ Exhibitor must arrive by 9AM on 6/15/24 and be fully set-up by 11 AM.
3. Company Representative/ Vendor/ Exhibitor must provide their own tent, table(s) and chair(s). No electricity provided.
4. Company Representative/ Vendor/ Exhibitor agrees to remain present with tent/table manned through the duration of the event (closes at 6PM) excluding weather conditions.
5. Company Representative/ Vendor/ Exhibitor shall keep their area neat and clean at all times and must pick up paper and debris around their rented space at the close of the event.
6. Company Representative/ Vendor/ Exhibitor vehicles must enter and leave by designated concrete sidewalks.
7. Any damage to the park's turf, plants, shrubs, flowers, benches, signs, monuments, trash containers, water fountains or other property will be the liability of the Company Representative/ Vendor/ Exhibitor.
8. No music is to be played as music will be centrally provided throughout the day.
9. Company Representative/ Vendor/ Exhibitor will not nail, screw or otherwise attach anything to columns, trees, etc.
